Governor Abbott,

As you are aware, the people of Texas have been vocal in their opposition to the direction of the United States, its unfair treatment of Texas, and its overt policies designed solely to subvert our individual liberties and sovereignty of Texas. In short, the United States is heading down a path that cannot and must not include the freedom-loving, hard-working people of Texas.

To this end, State Representative Kyle Biedermann has filed House Bill 1359 that will if passed, give the people of Texas a vote on the first step in withdrawing from the union and reasserting our status as an independent nation.

The Texas Nationalist Movement has received a clear mandate from the people of Texas on the issue of TEXIT. They want, at a minimum, an up or down vote on Texas reasserting its status as an independent nation. This fervor has led to an unprecedented outpouring of support for Representative Biedermann and his fellow authors of HB 1359.

Even with the issue of TEXIT dominating the political minds of Texas voters, you have been silent on your position regarding HB 1359 or even whether you believe that Texans should even be able to vote on the issue.

Your political party has made their support for this measure perfectly clear by the addition of Plank 65 to its platform in 2020, which reads, in part, "Texas retains the right to secede from the United States should a future president and congress change our political system from a constitutional republic to any other system."

The conditions of this plank have been met and exceeded, as attested by your very own public statements against the federal government's current policies.

Yet you have remained silent. Even in the face of insults hurled at Texans from the White House and Congress and affronts to our fundamental rights and our basic system of governance by the branches mentioned above of government and the Supreme Court, you have remained silent.

Governor Abbott, silence is consent and to have the head of state for Texas consenting to the further subjugation of the will of Texas voters is unacceptable.
